Approval of Minutes

Treasurers Report

Brenda Utlaut presented the following budget:

Old Business

A report was given by Tara Davis on the Glasgow Zine project that is being done by Devyn Monnig. The project is going well, and it is a 12-page document that highlights all of Glasgow's local businesses and provides a map. Can the cost of printing be split with Main Street? Also, can it be shared electronically on our website? The cost is \$1,020.00. Scott Morris made a motion to approve funds up to \$1,250 for printing and split the cost with the Main Street organization. Brenda Uthlaut seconded the motion. The motion passed.

Tara Davis gave an update on our Social Media presence and stated that 1,900 people have viewed our ads. All the businesses met the deadline for posting ads this week.

Kim Reckner gave an update on our Samaris website and stated that minutes and agendas of our meetings have been posted. The Wine Walk information is ready to go. As a point of information Ms. Reckner stated that 8% of gross revenue should be spent on advertising.

More information will be shared at our next meeting on the status of our 501(c) account with the state.

New Business

Lydia Wagy stated that Chamber needs a debit card to conduct business and make payments. The card would be issued in Brenda Uthlaut's name since she is the Treasurer.
